**Grounds:** Croton Creek Ranch, 4 miles west of Cheyenne, OK, on Hwy. 47, two miles north on paved road 1820, 2 miles west on gravel road 950. Signs will be posted. Single one-hour course on native and pre-released quail. **Drawing:** Friday, March 7, 7:00 p.m., at the home of Matthew Puckett. The AFTCA requires amateur handlers/owners have individual AFTCA membership (apply at [www.aftca.org](http://www.aftca.org)) for any amateur handler to receive a win certificate for their placement. **Lodging:** Croton Creek Hotel, cabins and RV hook-ups available on-site—(316) 847-2149; Bear Den Inn (alternate hotel), Cheyenne, OK—(580) 383-8759. Trailer parking, dog and horse paddocks on a first come, first served basis (or by reservation). **Food:** Meals and social hours will be in the Social Barn each day (Judges and workers complimentary).
