By registering your dog, you will commit to a \$65.00 per dog donation to the PCQC for the NBHA Gun Dog stake. **PCQC Membership:** To support PCQC research and habitat goals, please consider becoming a member (additional \$45 fee; membership not required but highly suggested). **Presentation:** A short presentation will be held at 8:00 a.m. by Ken Sauer and professional guests on what to expect in a field trial situation. If you have questions, please submit them prior to the event so we can move through this presentation quickly and thoroughly. Youth handlers are welcome! **Birds:** We will have birds planted/seeded along a 30-minute course. There will be ample opportunities for your dog to have bird contact. Dogs will be turned loose in pairs (braces). Depending on participation, we can utilize two units at the Grasslands if necessary. **Drawing:** Tuesday, April 1, 7:00 p.m., at Ken Sauer's home. If your dog(s) are aggressive or a female is in heat, we'll need to know this to draw you appropriately. **NBHA Field Trial:** After the Championship concludes, we will hold an NBHA-sanctioned field trial to help get your feet really wet and see what field trialing is all about. These events will require an entry fee listed below, and payment will be required if drawn for an event. We will forward you a running order for your approximate time. Ribbons will be awarded for the first three placements in each stake. Youth handlers are welcome!
