Directions to Grounds: Near Abilene, KS, exit I-70 at Abilene; Go south on Hwy. 15 for 20.6 miles. Entrance to farm is between 400 and 300 Ave., off Hwy. 15. Look for signs on west side of the road. Trial to be run on 3 one-hour continuous courses on native quail, prairie chickens and pheasants, with substitution of pre-released coveys. **Meals:** We have two of the finest chefs in the Midwest working with us to assure no one goes hungry!
