Directions to Grounds: Near Abilene, KS, exit I-70 at Abilene; Go south on Hwy. 15 for 20.6 miles. Entrance to farm is between 400 and 300 Ave., off Hwy. 15. Look for signs on west side of the road. Trial to be run on 3 one-hour continuous courses on native quail, prairie chickens and pheasants, with substitution of pre-released coveys. **Meals:** Lunch to be served daily; *Banquet*—Supper hot off the grill; All you can eat Seafood Boil (shrimp, crab legs, and all the other good stuff!) **Drawing:** Monday, March 16, 7:00 p.m., at the home of Secretary Diane Shoemaker. **Lodging:** Holiday Inn—(785) 576-9933, ext. 2 (ask for “Bird Dog Rate”) or Super 8 Motel—(785) 263-4545.
