Grounds: Valley View Field Trial Association Grounds at LBJ Grasslands, located 14 miles from Decatur, TX. The main gate to the camp and trial grounds are on CR 2777 near the intersection of CR2675 and CR2777. The VVFTA pavilion is on CR2777 (blacktop road; GPS Coordinates: 33.41044N and 97.58915W). There is a vehicle/family usage fee and is not included in your entry fee (\$10/day). **Hotels (in Decatur):** Hampton Inn, LaQuinta Inn, Fairfield by Marriott Inn & Suites, and Holiday Inn Express. Campsites are available and are primitive (no power). There is a windmill with water for horses. Please take your trash back out with you (no dumpster on site). Lunches served on grounds daily for \$10. There is a USFS daily use fee not included in entry fee (per vehicle). **Drawing:** Monday, December 7, 7:00 p.m., at Ken Sauer's home. Dogs' registered names, FDSB/UKC number, AFTCA Win Certificate number, and AFTCA Membership number are required at entry. **Courses:** We have two units to run on and may elect to utilize both units. They do connect as continuous courses. Both courses have been manicured thanks to the generous Sponsorships from the Park Cities Quail Coalition (PCQC) and the VVFTA Volunteers. The second course will be used as an overflow course and will not run continuously. **Qualifications:** An AFTCA membership number required at entry for amateur AFTCA points and placements. NBHA requires no membership. **Events:** Some companion events may not be held due to time and number of entries and is at the discretion of the hosting club.
