- **Grounds:** I-35 to Exit 29 (Rt. 70 East). At four-way stop, right onto Rt. 77 South. First left (across from ranger station) into Group Camp/Trial Grounds. Stay left to the grounds. There is a clubhouse at the grounds as well as restrooms/showers. Campsites are available for \$35/night with power and water; \$30/night with power only; or \$25/night with no services.
- **Lunches:** Lunches will be available each day at a nominal cost.
- **Drawing:** Tuesday, January 3, 7:00 P.M., at the Gustafson residence, 8305 Elroy Rd., Del Valle, TX 78617.

- **Daily Running:** Six (6) one-hour braces are scheduled each day; however, in the event of an early termination of a brace, the 7th brace will be on standby. NO cell phone use during the running of braces. NO smoking is allowed on the grounds.
- **Qualification:** It is a condition of acceptance for the Championship that each entry furnishes an AFTCA Win Certificate number for a Derby or Shooting Dog Placement (1st, 2nd, 3rd) for both dog and handler per AFTCA Bylaws Article III, Section 8, and dogs must be entered by their registered name. Entry fee is expected if dog is drawn. Owners and handlers must be members of the AFTCA. Please include your individual AFTCA membership number with your entries.
- **Prizes:** Purina dog food and Garmin watches to champion and runner-up. Awards to all placed dogs in the Derby.
