

2024-25 Dog of the Year Winners

he five Michigan Coverdog clubs run 12 grouse and woodcock trials every season, from August through the spring of the following year. Three standing Championships run each Michigan The Woodcock Championship, The Northern Michigan Cover Dog Championship, and we finish the fall season with the oldest of all. The Lake States Grouse Championship. The balance of the 12 trials are weekend events. running all three classes of field trial stakes: Puppy, Derby, and Shooting Dog. To qualify for any of the awards, dogs must run in a minimum of three events and place in a minimum of two events. Points are awarded by a dog's placement and the number of dogs entered in the event; the more entries, the more points awarded.

Michigan Coverdog Puppy of the Year

Winner: White Indian Outlaw, a pointer male handled by Tom Butler and owned and trained by Tom and Rachel Butler. Outlaw placed in three events, winning two first-place and one second-place showing. Tom and Rachel are looking ahead to Outlaw's derby season.

1st, Bryan Wood Puppy Classic (13 entries); 1st, Brittany Club Spring Puppy (nine entries); and 2nd, Michigan Puppy Classic (six entries).



Heartbreaker Bud Light

Runner-up: Heartbreaker Bud Light, pointer male, owned by Tom Butts, trained and handled by Tammy Chaffee. Bud Light also earned three placements, including a single first-place finish and two second-place finishes.

1st, Bernie Baumann Puppy Classic (11) entries; 2nd, Bryan Wood Puppy Classic (13 entries); and 2nd, Brittany Clubs Spring Puppy (nine entries).

Michigan Coverdog Derby of the Year




Shane Haskins with Hattan Hills Luci



ALABAMA YOUTH HANDLERS AWARDS CEREMONY

2024-25 Youth Handler of the Year Winners

■he Alabama Youth Field Trial Association celebrated its 23rd annual Youth Handler of the Year awards on June 14, 2025, at the Union Springs Country Club. The express purposes of the AYFTA is to help perpetuate the sport of pointing dog field trials, promote youth involvement in the sport, provide opportunities for outdoor activities, to positively impact youngsters by teaching life lessons and building character, teaching sportsmanship and teamwork, and to expose field trials and its associated wildlife to youngsters all over the South.

Alabama youth field trials began 40 years ago. The first documented one was a small field trial in Fitzpatrick, Alabama, with just four or five kids under the age of 17. AFYTA now has seven annual vouth field trials, some with over 20 dogs entered! AYFTA has taken the lead in promoting youth field trials in America. Field trialers around the country have taken note of our success in building the sport. Oregon, Connecticut, Pennsylvania, Tennessee, Massachusetts, especially Georgia, have joined the fun. Much of the nationwide growth can be attributed to Chris Mathan and Claudia McNamee of Georgia. who administer the Youth Field Trial Alliance website that posts youth trial news across the nation. If there is any doubt that youth trials are making a difference, one needs to look no further than the accomplishments and contributions former youth handlers are making in the sport. A former Alabama Youth Handler has won the National Open Shooting Dog Championship. Another has scouted a National Open Shooting Dog Champion. Many other former youth handlers have competed in and scouted in National Championships. Several have won or placed in countless recognized stakes. Previous youth handlers routinely judge and report

major adult stakes. The results are undeniable.

In 2002, the AYFTA placed into competition a revolving trophy for the annual Alabama Youth Handler of the Year. In 2009, the Hartley Carter Foundation was established to provide a \$1.000 post-high school educational scholarship to each subsequent youth handler of the year. It has paid over \$8,000 in scholarships so far. In 2017, the AYFTA placed in competition a revolving trophy for the runnerup youth handler of the year, and a \$500 Hartley Carter Foundation annual scholarship was initiated for its winner. Missy Lawrence and Lisa Littell manage the 501(c)(3) Hartley Carter Foundation. In 2020, a Junior Division was introduced for handlers aged 12 and under. This year, written guidelines for AYFTA youth trials and handler points calculations were officially adopted by the Alabama Field Trial Association.

This year, AYFTA had seven Alabama youth trials with a total of

103 entries. Nine different handlers earned points toward the Top Handler award. Four of the Alabama trials are also Dixie Trace Field Trial Association points trials, and six of them are also Southern Bird Hunters Association points trials.

This year's Junior Handler of the Year award, for the third consecutive year, is 11-year-old Hayes Green of Union Springs, Alabama. Hayes took Top Dog at the Bama Quail, Greenway, Mike Reynolds Memorial, and Shenandoah trials. Hayes is not only an exceptional handler, but he is also a straight-A student at Conecuh Springs Christian School. Hayes also enjoys fishing and playing baseball. For his achievement, Hayes received the Pat O'Neal Memorial revolving trophy, a 28-gauge O/U shotgun donated by Pat McPherson of Burnt Corn, Alabama, and a 5-troy ounce commemorative silver bar donated by Chris and Cynthia Sellers of Selmer, Tennessee. Hayes is also the reigning Dixie Trace Junior Handler of the Year.

One single point separated the two top youth handlers this year. Seventeen-year-old Addison McDuffie of Cecil, Alabama, was awarded the Johnny Capps Memorial AYFTA Runner-Up Handler of the Year trophy. She also received a leather gun scabbard from Pat McPherson, a 5-troy ounce silver bar from Chris and Cynthia Sellers, and a \$500 Hartley Carter Scholarship. Her points came from a first place at Bama Quail, third at Mike Reynolds Memorial, third at Greenway, third at Central Alabama, and a third at Shenandoah Youth trials. Addison is about to start her senior year at Pike Road High School, where she is a straight-A student. She is a member of the National Honor Society, a leader in the Future Farmers of America, actively engaged in her church youth group, plays violin in her school string band, and is

dual-enrolled at Auburn University. Addison is a four-time AYFTA Handler of the Year, two-time Dixie Trace Handler of the Year, two-time Southern Bird Hunters Handler of the Year, and four-time runner-up AYFTA Handler of the Year. She is undoubtedly the most accomplished youth handler in America.

This year's Youth Handler of the

Year is 14-year-old Madilyn Tilley of Greensboro, Alabama. Madi, as she is affectionately called, is starting ninth grade this year and is already an accomplished equestrian. She has even started training her own bird dogs and has her sights set on Veterinary School after college. Madi won first place at the Conecuh Station and Greenway Youth trials

and second place at the Central Alabama event. What a year for Madi! She was also named Dixie Trace Handler of the Year. Madi will receive a \$1,000 Hartley Carter Scholarship when she furthers her high school education. Her name will be forever enshrined on the John William Barnett Memorial revolving silver trophy. Madi also received a silver engraved belt buckle from the AYFTA and a 10-troy ounce silver bar from Chris and Cynthia Sellers.

ASSOCIATION OF SOUTH CAROLINA FIELD TRIAL CLUBS

South Carolina Field Trial Community Gathers for Annual Meetings and Awards By Katie Courtney | Pamplico, South Carolina

n Saturday, June 7, 2025, the Association of South Carolina Field Trial Clubs (ASCFTC) held its Annual Meeting in Pamplico, South Carolina, for a day of business, recognition, and camaraderie. Around 50 sportsmen and women from South Carolina, North Carolina, and Georgia attended the event.

The meeting opened with a warm welcome and introductions of the current officers: Mac Stidham (President), Drew Bastain and Gray Watson (Vice Presidents), Paul Kelly (Treasurer), and Katie (Secretary). Attendees Courtney were invited to purchase raffle tickets and ASCTFC t-shirts, with proceeds supporting the association's ongoing efforts.

Special thanks were extended to Kent Carraway for hosting the event and to Raleigh Lowder of Quail Forever and South Carolina Department of Natural Resources, who generously contributed to the raffle and spoke briefly on the organization's conservation work and partnership opportunities with the field trial community.

A Year of Growth and Gratitude

The 2024–2025 season proved active and successful, with 11 trials held and a total of 615 dogs entered. Horseback stakes led the way with 412 entries (211 Open, 201 Amateur), while Walking stakes drew 203. The South Carolina Open Championship saw 51 Shooting Dogs and 14 Derbies compete, while the South Carolina Amateur Classic hosted 24 Shooting Dogs.

The ASCFTC extended gratitude to key supporters, including Purina, Kalmbach Feeds, Southern Pines Land & Timber, and Gun Dog Supply. Looking ahead, leadership emphasized the importance of exploring sponsorship opportunities

to help reduce trial costs and expand access to new participants.

Financial Update & Club Business

A financial overview was provided, with Treasurer Paul Kelly available for follow-up questions. The 2025–2026 trial schedule was distributed, with reminders to check americanfield.com and ASCFTC Facebook for updates.

New Initiatives & Invitational Announcement

The association announced no dog tax for the upcoming season and several exciting new awards for next year, including:

- A custom portrait for the Amateur Shooting Dog of the Year
- A \$500 cash award for Amateur Handler of the Year (inclusion of open placements for amateur points if no prize money is accepted and an AFTCA win certificate is given)

Perhaps most exciting was the announcement of the South Carolina Amateur Invitational, scheduled for March 14–16, 2026. Hosted on wild birds at a private plantation, the event will invite the top 12 Amateur Shooting Dogs of the season.

Celebrating Excellence: Award Winners

The meeting concluded with the much-anticipated award presentations:

Open Shooting Dog of the Year: Belle Star ("Belle"), owned by Stanley McCain and handled by Scott Miller.

Open Derby Dog of the Year: Zero Tolerance ("Buzz"), owned by Marty Moore and handled by Scott Miller, dominated with multiple first-place wins.

Amateur Shooting Dog of the Year: B K Bonafide Stallion, owned and handled by Harry Cook III.

Amateur Derby Dog of the Year: Saturday Night Special ("Uno"), handled by Cook, showed strong promise for next season.

Walking Shooting Dog of the Year: Hirollins Gone and Doneit ("Gunner") retired on a high note as Walking Shooting Dog of the Year, owned and handled by Warren Parrott, who also earned Amateur Handler of the Year, edging out stiff competition.

Open Handler of the Year: Tony Bingham.

Taking home the red was another setter, a classy tri-color female named Misfire ("Daisy"), owned by Paige Davis and handled by Deb Kennedy. The inaugural running of the Peter Mooney Open Shooting Dog stake had a nice entry of 18 dogs. Peter was a stalwart member of the Maine Bird Dog Club for many years until his untimely passing last year. His son, Parker, was on hand to witness the awarding of the handsome rotating trophy to Peter's dear friend, Kellie Short, for her first-place female setter, Paucek's Dormin. Handled by Adam Dubriske, the second place went to Mike Rosano's strapping orange and white setter, Super Storm Cliff. Cliff is always in the mix in any stake he enters; he is beautiful on point, fast, and forward at all times. Taking home the third was Frank Joyal's pointer female, Carolina's Great Pee Dee, who is a threat when she enters a stake. A special thanks to judges Jon Cullen and Roy Hargreaves, who had the biggest stake and the most rain.

Kellie Short's dogs took both the first and second places in the Amateur Shooting Dog stake. Dormin took home another blue, while her packmate, Ch. Paucek's Little Tommy Tucker, a setter male, garnered the red. Roy Hargreaves's Owsley, a French Brittany, took home a well-deserved third place.

The Amateur Derby blue ribbon went to Still Meadow's Little Sunray,

a setter female owned and handled by Kelly Hays. Ray continued her winning ways with a mannerly find and handled nicely for her owner. Second went to Jim Hathaway's big male setter, "Tune," who found and pointed numerous quail with great enthusiasm, although his braking mechanism was not fully engaged. Taking home the yellow ribbon and her second derby placement of the trial was Paige Davis's Misfire. Paucek's Little Tommy Tucker Named Champion; Neo, Runner-up By Deb Kennedy | Brownfield, Maine | May 17, 2025

inning his third title and his second within the year was a tri-color setter, Paucek's Little Tommy Tucker, owned, handled, and trained by his proud owner, Kellie Short. The runner-up title went to Neo, an orange and white male handled by owner Dave Theroux, who has guided his prized champion through a difficult year of rehab to this stunning comeback.

Judges Jamie Leitch and John Malone had a day's worth of judging for the host club, Maine Bird Dog Club, on the Brownfield, Maine Game Management Area. The experienced judges oversaw a field of fine dogs and eager—at

times, perhaps overeager—amateur handlers and named the winners quickly after the last brace. Judges' jackets, handsome plaques, and dog food for the winners were provided through AFTCA's Purina sponsorship program.

The judges reported that Tucker was in all the right places for his hour, scouring the grounds and carding five perfect, high-headed finds and a mannerly back. Tucker comes from a long line of famous champions. His sire, Ch. Long Gone Wallace, was the son of the legendary Ch. Stillmeadow's Jim. Tucker's dam, Paucek's Hickory Roxy, is backed by a line of Paucek-bred champions, including Ch. Paucek's Ruby, Ch.

Paucek's Tommyknocker, and Ch. Paucek's Fauntlerov.

Tucker ran in the fifth brace and had the course to himself after his bracemate's forced error early in the hour. (Insert handler's swearing here.) By the afternoon, there were many quail on the course and beyond, especially since there had been three quail events within two weeks on the grounds. The bird numbers challenged the composure of both dogs and handlers.

Tucker's race was big and forward, and his finds had the handler and both judges scouting through the heavy spring cover. Tucker didn't care who found him as long as Kellie was there to flush the bird. While this was an amateur championship, Tucker behaved like a seasoned pro. His trial history tells why. He was New England's Open Puppy of the Year in 2018, placed third in the Woodcock Futurity, won the Jean Sanderson Memorial Open Derby on woodcock, was named champion in the New England Open Woodcock in 2021, and won runner-up champion in the same event in 2024. He's had more than 20 placements during his career. On top of it all, Kellie reports, he's just a nice guy, a perfect gentleman in the house.

Runner-up champion Neo was purchased as a puppy by Dave Prince and Dave Theroux from Robert Ecker in 2019, who kept him through his derby season, placing him several times. In June of 2021, Dave brought Neo to his camp in northern New Hampshire. The young, eager setter took what amounted to a college course in grouse and woodcock with Dave chauffeuring him to remote covers loaded with wild birds. All that woods experience did the job. A year later, at just three years old, Neo was named runner-up champion in the New England Open Woodcock Championship. Two days later, in the rugged terrain of New Hampshire's White Mountains, Neo won the New England Open Grouse Championship under pro handler Adam Dubriske. Last year, Neo had ACL surgery for a blown knee and then needed to have a detached retina repair. After an intense rehab period, the orange and white setter was finally cleared to run. Dave got him back in shape and into the birds Neo loves, all of the pain and effort paying off with this latest title.

Neo is the son of Ch. Sterlingworth Jack, who is the son of Shadow Oak Bo, the two-time winner of the National Championship. Neo's dam, Sandland Miracle Maggie, is from

the Commander line of foundational modern field setters. As laid back as he is in the house, Neo is all business in the woods with a solid forward race coupled with perfect manners on his birds.

The heartbreak dog had to have been Gregor McCluskey's rugged red setter, Braeval's Rory. Blisteringly fast and powerful, he was braced with Bob Arkley's equally impressive English setter, Lightning Flash Dude. Toward the end of the brace, Rory's bell went silent. After a search, Gregor sent out Kellie Short as his scout, but not long after, decided the dog had been gone too long and asked the judge for his tracker. Seconds later, just around the bend,

the gallery was treated to Rory on a stiff point, the bird crouched only inches from his nose. Kellie Short popped out of the woods just a minute too late. Equally disappointed and amazed that the dog was so incredibly staunch, Gregor asked for permission to flush for his dog, and when the forward party was far enough ahead, Gregor flew the bird for his dog, who never moved a whisker.

Not quite as dramatic was the quail that escaped from under a log and leapt into a deep pool in front of Kellie Short's other entry, Paucek's Dormin. The quail did a passable breaststroke, but Dormin took one step too many when she went to take a look for herself.

he awards committee gathered on Saturday, June 21, at the Embassy Suites by Hilton Oklahoma City, Oklahoma. Committee members present were Chair Sean Derrig, Rick Stallings, Tom Griffin, Mike Husenits, and the writer Mark Johnson. Also present were Greg Blair and Scott Johnson, representing Purina, and Dominick Muoio, representing the United Kennel Club.

The meeting was called to order at 8:10 a.m. All engaged in discussion about the tremendous contributions Mr. Dwight Smith has made to this committee and to the field trial community in general. Dwight's passing just days before this meeting came as a shock to all, and it would be a sincere understatement to say that his sage, measured, and balanced contributions to this group were anything less than outstanding. He will be sorely missed. RIP, Mr. Dwight!

Following the distribution of this year's workbook, the committee got down to business, starting by reviewing the roster of the current year's program winners, both dogs and handlers. The spirit of robust competition showed itself in several categories for the 2024-25 season. In some cases, the winning person/dogs were determined in those last trials of the season. A detailed listing of the season's winners appeared in the July 2024 issue of the UKC® Field.

The prior year's meeting minutes were reviewed without further discussion. The updated handlers list is indicated below and is referenced in the Shooting Dog Roster for the upcoming season.

A discussion regarding the program's STANDARDS AND OPERATING PROTOCOL ensued. Two (2) handlers were removed from the "Handler's list" due to multi-year

inactivity, and four (4) were added. Handlers wishing to be added to said list need to apply to the committee for such recognition while confirming that they have handled their own string of dogs for not less than the prior three years. The updated handlers list is indicated below.

Again, policy regarding changes to leadership, venue, or dates for points trials must be approved by the committee. For purposes of points calculation, the long-standing policy multiplier continues to be based upon DOGS DRAWN. All shooting dog points trials must be reported to Mike Luebke @ trialpoints@outlook.com. It was again noted that points trials cannot limit entries. This year, there were no trials "dropped" for failure to report results for two consecutive years.

The next topic involved a careful review of new applications for PURINA POINTS consideration. Seven (7) applications were unanimously approved. Each of these clubs has received written confirmation that their application has been approved and will be listed on the 2025-26 season's rosters.

The committee discussed and ratified that the current breakdown of dogs/professional handlers would remain as is. That matrix is listed below and on the Shooting Dog Trial Roster for the upcoming season.

A private business matter was then discussed. With no further business at hand, the meeting was adjourned at about 10:30 p.m.

The Purina Awards Program is sponsored by Purina PetCare (Purina) and enjoys a long and extensive history of recognizing superior performances, handlers, and bird dogs in the field trial sport. The Top Field Trial Bird Dog Award (all-age) was established in 1963 and was sponsored by Purina. From the start, the Purina Awards Program

was designed to stimulate interest in all field competition and recognize publicly the dog and handler which had excelled in a given field trial season. Over time, the program has evolved and expanded to include the Open Shooting Dog, Open Derby, Open Handler, Amateur Shooting Dog, and Amateur All-Age categories.

The primary role and responsibility of the Awards Committee is to administer the Purina Awards Program. This includes but is not limited to determining the manner in which the program shall be conducted, establishing a points system to determine the leading handlers and dogs, selecting trials where such points may be earned, and making determinations regarding other matters that may be related to the proper conduct of the Purina Awards Program.

The Awards Committee also carefully and consistently complaintsinvestigates written protest and/or negativity/conduct relative to Purina Awards Program events. Misconduct will not be tolerated and will be addressed decisively. When appropriate action is needed, it may include, but is not limited to, loss of points, loss of eligibility to be named handler/dog of the year, or both. In all cases, when a handler chooses to compete in a trial awarding Purina points, they agree to compete under the oversight of the awards program. The same applies to clubs and championships that officiate approved Purina Points events.

Application for Recognition in the Program

In general, we are mindful that Purina Points trial status is not a given or automatically granted position. Purina Points trials must, in all cases, be reflective of premier bird dog competition, held on premier

showcasing venues. top-notch handler and dog capabilities in a sportsmanlike and publicly appealing package. Purina Points trials and championships must also reflect baseline respect and appreciation the MAJOR sponsorship contributions Nestlé Purina and the Awards Committee contribute to this significant and unrivaled bird dog awards program. Pertaining to new program applicants, an official application form must be submitted to the Awards Program recording secretary. New applications will be reviewed and acted upon by the full committee at their annual June committee meeting. Completion of an application does not quarantee approval. Typically, a three (3) year probationary time frame precedes approval.

Advertisement Requirements for Recognized Awards Program Events

- The Purina checkerboard logo must appear prominently in all points trial ads.
- United Kennel Club policy regarding the size of ads will prevail.
- Ads must appear in the UKC® Field/website well ahead of the start of the event.
- Judges' full names must appear in the ad. Judges "TBD" is unacceptable and can be cause for a club to lose points status. Likewise, changes in listed judges must be communicated to UKC and the Awards Committee.
- The starting date, venue, and stake particulars must appear in the ad.
- The Awards Committee must be notified of any and all changes to the running of a recognized and advertised Purina Awards Trial via written/email notice to the recording secretary.

Standards and Protocol

• To qualify for annual points consideration, recognized Purina Awards Program points events must run a minimum of 16 dogs (Derbies excluded). This standard has been

in place for several years and reflects the program's intent to attract a broad event base reflective of the stature and prestige associated with the program. Those approved events that are run but attract less than the 16-dog minimum must nevertheless report the fact that their trial was run, including submission of a running order (Open Shooting Dog stakes only) and the completed Form for Essential Data.

• All points trials must be reported to appropriate parties and the Awards Committee within 45 days of the event's conclusion. Points WILL NOT BE SCORED for clubs that fail to report results within 45 days of event completion. "Reporting" is defined as the submission of Form for Essential Data to the Open and

Amateur Shooting Dog points Luebke-at tabulator—Mr. Mike trialpoints@outlook.com, along with a running order (for Open Shooting Dog stakes only) that indicates the dog's FDSB name and the handler's full name. Points WILL NOT BE SCORED for Open Shooting Dog stakes that fail to include a complete running order with their Form for Essential Data. trialpoints@outlook.com the only acceptable manner communicate results to Mr. Luebke and becomes the basis for his paper trail supporting his calculations. Open All-Age and Amateur All-Age stakes must be reported to the United Kennel Club in the traditional manner.

- Clubs/Championships failing to report for two consecutive years will be dropped from the roster.
- Any change in venue must be approved by the Awards Committee.
- All dogs, handlers, owners, and club officials participating in approved Purina Awards Program field trials must be in GOOD STANDING with the *FDSB*/United Kennel Club. Additionally, clubs/championships that elect to accept entries from persons/dogs not in good standing with the *FDSB*/United Kennel Club effectively relinquish their status as a Purina Points trial.

- All federal, state, and local ordinances apply to points trials.
- Failure to comply with any of the above points will result in a loss of Purina Points for that trial and may include suspension from the Awards Program.

Professional Handler

- Within the context of the Purina Awards Program, a professional handler will be defined as a person or persons who has actively competed in American Field/United Kennel Club-sanctioned bird dog field trials for at least three consecutive seasons, with his own string of dogs numbering not less than three (3).

- Handlers indicated on the abovereferenced list may be purged from subsequent years' listings due to inactivity in Open Shooting Dog Purina Points trials during the preceding year(s). Listed handlers will be expected to keep the Awards Committee aware of changes that would preclude their being listed.
- Consideration for additions to the approved professional handlers' roster can be made in writing and directed to the Awards Committee Secretary or any committee member. Such applications should indicate name/contact particulars and Kennel name, a summary of prior 36 months of handling dogs professionally, and a listing of Purina Points trials where dogs were handled as a professional. Consideration for additions will be at the committee's summer meeting.

Approved Points Trial Roster

• Annually, the United Kennel Club will publish a roster of approved Purina Points field trials—open, amateur, shooting dog, all-age, and derby.

 It is the responsibility of each Club to confirm they have been listed.

Shooting Dog Points Calculation Particulars

- The 16-dog minimum prevails with a minimum of three (3) active professional handlers
- For stakes with 17-24 dogs entered, there will be a minimum requirement of four (4) active professional handlers for points to be counted.
- For stakes with 25 or more dogs entered, the requirement is five (5) active professional handlers.
- In cases where the threshold number of professional handlers, as described above, is not met, points will be calculated at the level corresponding to the actual number of professional handlers participating. For example, if an Open stake drew 30 dogs, but there were only three professional handlers, points would be calculated at the 16-dog level.

Once again, these criteria are not intended to be burdensome or bureaucratic. Rather, they are specifically intended to reflect the prestige and stature of recognized Purina Points events by creating a more inclusive and broader base of competition in the shooting dog category. Club officials are most certainly encouraged to reach out

to area professional handlers, encouraging them to join their field trials with the intent to win, but also ensuring that maximum points thresholds are met for points calculation purposes.

- A three (3) dog bye brace limit will be in effect for awards recognition. Points calculations will be reduced accordingly for excesses. For example, if a stake drew 36 dogs, six (6) of which were drawn as bye dogs' points would be scored for a field of 33 dogs only.
- Awarding of Points: One-course trial venue will receive half points, while three (3) courses will receive full points based on the number of dogs entered.

63rd ANNUAL PURINA TOP FIELD TRIAL BIRD DOG AWARD

The Purina Award was initiated in 1963. All dogs earning Purina Points in a given season must be DNA certified.

Owner of the dog emerging as the season's Top Field Trial Bird Dog will be awarded an original oil painting of his dog. Handler of the winning dog will receive a cash purse of \$2,500, which will be doubled if the handler is an active Purina Pro Club® member, redeeming within the previous six months.

The National Open Shooting Dog Championship will award 500 bonus points, the United States Shooting Dog Invitational Championship will award 400 bonus points, and the International Endurance Open Shooting Dog Championship will award 100 bonus points. Trials have been carefully selected on longevity of the supporting organization; grounds; heats of one

2025-26 PURINA TOP AMATEUR SHOOTING DOG AWARD

The Amateur Shooting Dog Award program is administered by the Purina Awards Committee and designed to elevate the level of competition—to make known to the public those contenders which consistently outperform their competition.

Likewise, this amateur "owned and handled" award is based on a point system for winning dogs of top-flight amateur shooting dog stakes. Points are awarded based on the number of dogs officially drawn: 1st place will receive 10 points for each dog drawn, 2nd place will receive 5 points and 3rd place will receive 3 points.

The National Amateur Shooting Dog Championship winner will receive 250 bonus points;

the runner-up 125 bonus points; the National Amateur Shooting Dog Invitational and National Amateur Free-For-All winner will receive 200 bonus points each. The National Amateur Shooting Dog Invitational runner-up will receive 100





bonus points. If placements are withheld or voided, no points will be awarded. If a point trial is held twice in one season, Purina Top Amateur Shooting Dog Award points will be credited for the first event only.

Trials have been selected on longevity of the supporting organization; grounds; heats of one hour; expedient, accurate reporting; prestige; and geographic location. The Awards Committee reviews the points system and trials each year. Only amateur trials which meet the highest standards will be included. Points season ends April 30, 2026.

Those who chose to enter and compete in Purina


