

## William Dwight Smith October 19, 1937 — June 7, 2025

Dwight Smith, 87, of Norwood, peacefully passed away at his home on Saturday, June 7, 2025.

Born in Stanly County on October 19, 1937, Dwight was the son of the late Lenox and Georgia Smith. He was preceded in death by his beloved wife, Barbara K. Smith, in 2015, and his brother, Darrell Smith.

Dwight is lovingly survived by his children, Ardie Smith (Denise) of Norwood and Lynn Dender (Ray) of Charlotte; grandchildren, Will Chilton (Justine), Zach Smith (Megan), Amber Todys (Sam), and Carly Smith (Jacob Buchholz); great-grandchildren, RJ and Elias; and special friend Sandra Stone.

Dwight dedicated his life to public service and his community. He served as Mayor of Norwood from 1974 to 1984, followed by his tenure as Chairman of the Stanly County Commissioners from 1991 to 1995. From 1996 to 2015, he served as Norwood's Town Manager. He was a member of the prestigious North Carolina Order of



the Long Leaf Pine Society.

A lifelong entrepreneur, Dwight operated Smith Foods Store and several other local businesses.

Dwight's faith was central to his life. He was an active member of First United Methodist Church Norwood, where he taught Sunday School and held numerous leadership positions. His love for his family and community was unwavering. He believed deeply in the importance of community involvement, humility, and service to others.


Dwight was a great ambassador for field trials and believed in fairness as a top priority. He was a servant to Hoffman, always working behind the scenes in his sportsmanlike without manner seeking recognition. He was an active member of the NC Field Trial Association and served as President and Secretary/Treasurer. Dwight was a major player in attaining the use and development of Hoffman field trial grounds. He served as judge and reporter to the American Field for various field trial associations. Dwight led the effort to establish the Top Shooting Dog Award that we know today as the Purina Awards. He served The National Open Shooting Dog Championship as Secretary, President, and Board of Directors Member for 10-15 years. He also served as chairman of the U.S. Quail Shooting Dog Futurity for at least 10 years.

Dwight hosted the winter training program for the Tracys in North Carolina for many years.

n 1970, Nida and I went to watch our first field trial near Knightdale, North Carolina, with our field trial friends, Mike Gaddis and his wife, Loretta. Mike was a hunting partner and friend, and later in life became a writer and senior editor for Sporting Dog Classic magazine and author of Zip Zap, Jenny Willow, and several other sporting life novels.

It was common, starting the first weekend after quail hunting season and throughout the next month, for field trials to be held in most rural counties in North Carolina. The trials were held in small fields with mowed strips where quail would be planted for the dogs to hunt. Each brace, two dogs and their handlers would hunt this field for approximately eight minutes while two judges on golf carts followed behind them. Handlers with their pickups and staked-out dogs would be on the hill overlooking the bird field, watching the performances. It reminded us of a tailgate, and yes, there was usually a pig picking lunch for all the field trialers, their wives, and their children to enjoy—a family affair. Entry fees were affordable, and fun was had by all. This is where most of us field trialers had our start!

We watched a man showing his English setter, Rip, who pointed many birds in his allotted time. The setter had great style and great distance with each point. After Rip was named first-place, Mike, Loretta, Nida, and I walked over and congratulated him and his beautiful setter. He introduced himself as Garner Dement.

We continued our love of quail hunting throughout the '70s and '80s. In the late '90s, quail became scarce, so we turned to field trialing to continue our love of the sport. We were fortunate to have an English pointer, U. S. Complete

National Champion Britt's Bud Lite, who was given to us as a one-year-old dog with lots of potential as a Christmas present by our Uncle Harold Britt to start our wins in field trialing. As we were running Bud in trials, one of the first people we saw was Garner Dement. He was still winning with class bird dogs at U.S. Complete and National Bird Hunters trials.

Garner grew up on a tobacco farm in rural Louisburg, which is still his home today. Garner was a star athlete. As a kid, every afternoon that Garner was not involved in basketball and baseball, he would go quail hunting. As a ten-year-old boy in the 1940s, he carried a 410 single-barreled shotgun when hunting with his dad, who carried a 12-gauge double-hammer shotgun.

As a young man, he was 5'7", 160 lbs., muscular and country strong. Garner spent many hours training and hunting his own dogs. Garner's dog, Rip, continued to win. He had 23 placements in a limited number of trials since they were held only before and after hunting season. Rip was hunted all season on wild birds. Garner has had many other outstanding dogs. One was Butterfly with 26 placements.

After working as a supervisor at a furniture manufacturing supply company for 27 years, Garner turned to being a full-time pro dog trainer and handler. Garner is recognized and admired as one of the best bird dog trainers throughout North Carolina, South Carolina, and Virginia. Throughout his career, he has trained and developed 1,502 dogs for professional and amateur handlers. This is hard to believe but true! Dog number 1,502 that he trained was for Bob Lanier to be handled by pro Jerry Raynor. Interesting how everything comes full

circle. Garner has known Jerry since he was a young boy when he was planting birds at his Uncle J. W. Sorrell's fun trials at Dunn. North Carolina.

Garner's training grounds are located behind his house in a small bird field with mowed strips of broomsedge alongside an old tobacco barn that held quail and pigeons for training. It was a familiar scene daily to look across that field and see Garner with an old rope draped over his shoulder, whistle around his neck and pistol in his hand ready to flush for the English pointer pointing a quail and an English setter backing him while with his roughish, deep, growling voice Garner was saying "whoa" to the dogs.

Over these years of training, Garner has kept a notebook with training notes about each of the 1,502 dogs. Some of the dogs were: Pretty Run Smokey, Hobbs Pete Rose, Sugarknoll Trader, Grateful Spirit, and many others. Garner has been asked many times what his recipe was for training so many dogs so quickly, and Garner replies, "There really is not one. Every dog is so different. You have to read each dog and use a lifetime of

80+ years of experience. When an owner leaves his dog with me, he is not left in the kennel. He spends his time on a check cord with me."

Garner retired from dog training in 2024 at the age of 92. He tells everyone he has lived a complete life—training dogs, tending his one-acre garden, and sharing its bounty with family and friends. He has spent his life with the love of his life, his wife, Brenda, for 63 years, and has enjoyed his three daughters and many grandchildren and greatgrandchildren. He loves attending all their sporting events.

Our friendship with Garner has lasted more than 50 enjoyable years. In April 2025, we held a fun trial at our farm, Hunter's Creek Kennels. When Garner and Brenda got out of their car, they were enthusiastically greeted by many long-time field trial friends. And then the great stories began to be told.

Thank you, Garner, for the man you are and for serving our country as an MP in the US Army. Courageous men like you allow all of us to enjoy the freedom we have today.






